# MINUTES OF JANUARY 19, 2017 Public Meeting

#### AUTHORIZATION

The Defense Advisory Committee on Investigation, Prosecution, and Defense of Sexual Assault in the Armed Forces ("the Committee") is a federal advisory committee established by the Secretary of Defense in February 2016 in accordance with section 546 of the National Defense Authorization Act (NDAA) for Fiscal Year (FY) 2015 and section 537 of the NDAA for FY 2016. The Committee is tasked to advise the Secretary of Defense on the investigation, prosecution, and defense of allegations of rape, forcible sodomy, sexual assault, and other sexual misconduct involving members of the Armed Forces based on its review of such cases on an ongoing basis.

#### **EVENT**

The Committee held its initial public meeting on January 19, 2017 from 10:04 a.m. to 3:54 p.m. The Committee received informational presentations on the court-martial process, recent legislation involving sexual assault in the U.S. military, and the two most recent predecessor Department of Defense panels on sexual assault: the Judicial Proceedings Since 2012 Amendments Panel (JPP) and the Response Systems to Adult Sexual Assault Crimes Panel (RSP). Following the briefs, the Committee held a planning session for Committee members to discuss the statutory taskings, topical priorities, and development of the Committee's strategic plan.

#### MEETING MINUTES

The Alternate DFO opened the public meeting at 10:04 a.m. Chair Martha Bashford provided opening remarks and summarized the agenda for the meeting.

# Welcome Remarks

The Honorable Jennifer M. O'Connor, General Counsel, Department of Defense, welcomed the Committee members and thanked them for their service. She outlined a number of reforms

already made in the area of sexual assault in the military and encouraged the Committee to consider certain topics as they develop their strategy. She noted that the Committee has the opportunity to make a lasting impact on the lives of those serving in the Armed Forces.

# Overview of the Court-Martial Process

Mr. Dwight Sullivan provided an overview of the military justice system, including the court-martial process and non-judicial punishment. He highlighted the differences between summary courts-martial, special courts-martial, and general courts-martial. Mr. Sullivan answered questions from the Committee about jurisdiction and recent legislative requirements, such as the requirement that all penetrative sexual assaults referred to a court-martial must be tried at a general court-martial.

# Legislative Highlights and the History of Sexual Assault Issues in the Armed Forces Since 2012

Captain Warren Record provided an overview of changes to military justice since 2012, highlighting that there have been more changes since 2012 than there had been in the previous 61 years. He noted that reaction to the RAND survey, which estimated that 26,000 Servicemembers were the victims of sexual assault, brought tremendous attention to the problem in the Armed Forces. His presentation focused on changes since 2012, including changes in the Fiscal Year 2014 National Defense Authorization Act. These changes included the requirement for all Services to provide victims with their own legal counsel. Captain Record also discussed the newly passed Military Justice Act of 2016, which mandates significant changes to the military justice system to further align it with civilian practices. Captain Record answered questions from the Committee members regarding the prevalence of sexual assault as compared to the number of Servicemembers court-martialed.

# <u>History of the Response Systems to Adult Sexual Assault Crimes Panel and the Judicial Proceedings Panel</u>

Ms. Maria Fried provided a historical overview of the membership, tasks, and work of the RSP and JPP. The RSP and JPP were established by Congress as part of an effort to understand and address sexual assault in the military. The RSP conducted a comprehensive review of responses to sexual assault. As part of this review, the RSP addressed the role of commanders in the military justice system and resources for victims, and conducted a comparison between the military justice system and civilian processes and procedures. The RSP issued 132 recommendations. The JPP was tasked more narrowly to review the implementation of certain Uniform Code of Military Justice reforms related to sexual assault, restitution and compensation, and victims' rights. The JPP has released five reports and is expected to release at least one more before it concludes its work in September 2017. The Department of Defense and Congress have implemented a number of the RSP recommendations while the JPP recommendations remain under review. Ms. Fried answered the Committee members' questions on the differences in the scope of the panels.

# Committee Planning Session

Chair Martha Bashford led a discussion about the scope of the Committee's work and its methodology. The Committee agreed to meet quarterly. The Committee agreed it would use Subcommittees to conduct much of the fact gathering but felt it was premature to decide the focus or membership of the Subcommittees until the Committee members had additional time to familiarize themselves with the issues. The Committee members further agreed that it would conduct case reviews, which would include review of both investigative files and records of trial. The Committee members did not feel they were limited to examining only those adult sexual assault cases that did not involve a domestic relationship, but would include all adult sexual assault cases in their review. The Committee members added they may look at cases involving minors in the future, but not during the initial review.

The Committee members agreed that they needed time to review prior reports and studies so they could make an informed decision on the scope and methodology that would provide the best data for their analysis. The Committee tasked the staff to provide them with previous reports and studies on sexual assault in the military and other reference materials to allow them to study the materials prior to their next meeting.

#### **Public Comment**

Mr. Don Christensen, President of Protect Our Defenders provided public comment. Mr. Christensen asked the Committee to review the reports by the Human Rights Watch and to consider the need to have experienced investigators and litigators handle sexual assault cases.

The Alternate DFO closed the public meeting at 3:54 p.m.
